President Ryan Britt welcomed everyone and called the meeting to order at 12:07 p.m. and reviewed the agenda. No revisions were added.

Ryan Britt stated that there will be elections in each of the areas this year and asked all the Area Directors if they had their nominating committees set up. About half do, the others will get the committee set up in the next few days. The time frame to meet the bylaws calls for ballots and background information on the nominees to be sent out to the districts by July 1. Districts can vote by attending the Area Meeting, submitting the vote by email to the nominating committee chair or sending by certified mail to the nominating committee chair. Odd number areas will elect for a 1-year term and even number areas will elect for a 2-year term. Starting in 2019 each area will have an election every other year for a 2-year term. Peggy can help send out the information to the districts and communicate with the nominating chairs.

The other agenda item is the issue of fraudulent emails being received that appear to come from Ryan Britt. He asked how many of the Area Directors had received them and it appears that 3 have so far. This will be submitted to the Attorney General's office. Ryan reminded everyone that he will never request any financial issue by email so any request like that by email will not be from him.

There being no further business a motion for adjournment was made by Beverly Dometrorch, seconded by David Morris. Motion carried unanimously (5-0). The meeting was adjourned at 12:40 p.m.
